### 6. DUTIES AND CONDITIONS

- (1) The position is the Principal Viola player of the City of Kyoto Symphony Orchestra.
- (2) You are to be engaged as a musician at Kyoto City Music Art Cultural Promoting Foundation, and the period of probation is for 6 months after signing a contract.

### 7. SALARY

- (1) The above-mentioned salary is an example of a standard initial monthly salary as of April 1, 2024.
- (2) Additional allowances such as a family allowance, a conveyance allowance, and a housing allowance will also be provided monthly according to each employee's conditions.
- (3) The average age of the orchestra members is 49 years old, and the average monthly salary is 398,314 JPY including allowances, as of April 1, 2024.
- (4) In addition, bonuses (an extra pay) will be offered. The total amount of bonuses actually paid in 2023 was as much as a total of 4.5 months' salary. However, the amount varies according to the time of employment, etc.
- (5) Concerning employee benefits, you can become a member of the Japan Health Insurance Association and the Employee's Pension as well as a member of the Kyoto City Employees Welfare Union.
- (6) If you have work experience, the number of years of your previous work may be added to your career as a member of the orchestra.
- (7) We have a retirement allowance system. The retirement age will gradually rise from 2024 to 65 years old from the end of 2031.
